-Captain Personnel-

- (1) Valid Airline Transport Pilot License
- (2) Aviation English Proficiency Certificate (Level 4 or above)
- (3) Valid First Class Aviation Medical Certificate
- (4) Aeronautical Radio Operator
- (5) More than Total flight 1,000 hours of flight experience as an Airline (Air Carrier) Captain(PIC) (Note 1)
- (6) Valid residence card and work visa

(Note 1) Flight experience is to be a Jet Aircraft (turbo fan), and includes experience with the airline of the ICAO party, and etc.. More than Total flight 1,000 hours are required at the point of entry, but you may apply even if your current experience is less than Total flight 1,000 hours (about Total flight 850 hours). The company may decide to recruit as a first officer depending on your experience, even if you meet the flight hour requirements.

-First Officer Personnel-

- (1) Valid Airline Transport Pilot License or Valid Commercial Pilot License (Multi Engine, Instrument Flight Certificate)
- (2) Aviation English Proficiency Certificate (Level 4 or above)
- (3) Valid First Class Aviation Medical Certificate
- (4) Aeronautical Radio Operator
- (5) More than Total flight 1,500 hours of flight experience as an Airline (Air Carrier) (Note 2)
- (6) Valid residence card and work visa

(Note 2) Flight experience is to be Jet Aircraft (turbo fan). For Airline Transport Pilot License holders, experience of airline of the ICAO party and etc. would also be included. For Commercial Pilot License holders, flight hours include experience of Japanese airline companies. More than Total flight 1,500 hours are required at the point

of entry, but you may apply even if your current experience is less than Total flight 1,500 hours (about Total flight 1,350 hours).
